Stichting JustdiggIt Foundation (hereinafter referred to as “JustdiggIt” or “JDI”), is issuing a Request for Quotation for Provision of a 4WD Station Wagon or Double Cabin 4WD Pickup. Details listed in Section II). The attached RFQ contains all necessary information for interested offerors.

Background:

JustdiggIt (www.justdiggIt.org) is a non-profit organization with a mission to regreen Africa and cool down the planet while creating benefits and opportunities for local communities. Our approach is to inspire and empower millions of subsistence farmers and pastoralists to regreen their land by combining Farmer Managed Natural Regeneration (FMNR, or Kisiki Hai) and water harvesting interventions with good grazing management.

So far, we have regreened over 60,000 hectares and brought back 5 million trees in Kenya and Tanzania. In the next 10 years it is our ultimate goal to reach 350 million farmers and inspire & activate them to restore all degraded land on the African continent. The above mentioned 4WD Station Wagon or Double Cabin 4WD Pickup will be used in rangeland restoration projects across Kenya.

Section 1 Instructions and General Guidance

1.1 Introduction

JustdiggIt (JDI), the Buyer, is soliciting bids from eligible interested offerors for the supply of a 4WD Station Wagon or Double Cabin 4WD Pickup.

1.2 Instructions for Offerors

1.2.1. Submission Deadline: Quotations must be emailed to eastaficafinance@justdiggIt.org no later than September 16th, 2022 (5:00 PM EAT). Quotations should be correctly identified with RFQ number. **RFQ No. 002/2022**

(Note: We are only receiving Quotations in soft copy.)

1.2.2. Inquiries: Interested Offerors can submit their questions to eastaficafinance@justdiggIt.org.

1.2.3. Restrictions on multiple submissions: Each offeror may submit a maximum of **three** Quotations. Submission of more than three quotations will result in disqualification of the interested offeror.

1.2.4. Communications: Upon issuance of this RFQ, JDI, its representative(s), or partners will not answer questions or otherwise discuss the contents of this RFQ with any potential Offerors or their representative(s), except for the written inquiries described in sub-part 1.2.2 above. Attempts to ask questions by phone or in person will not be allowed or recognized as valid. Failure to observe this restriction may disqualify the offeror.

1.2.5. Amendments: Any amendment to this request for Quotation will be communicated to all interested offerors and will be published on JDI official website.

1.2.6. Validity Period: Offerors Quotations must remain valid for 60 calendar days after the RFQ deadline.

1.2.7. Condition of the 4WD Station Wagon or Double Cabin 4WD Pickup: New or Second hand Vehicle (which is not more than 7 years old). The 4WD Station Wagon or Double Cabin 4WD Pickup must be covered by the seller's warranty.

1.2.8. Insurance: The 4WD Station Wagon or Double Cabin 4WD Pickup will be insured by the offerors until the vehicle has been delivered at the location of JDI's choice. Any loss and damage during the shipment will be to the offerors.

1.2.9. Terms of contracts: This is a request for Quotations only and in no way, obligates JDI to award a contract. In the event of contract negotiation with a successful offeror, JDI will use a firm fixed price contract. A binding contract shall consist of: (1) the RFQ and any amendments thereto, (2) the offeror's response (Quotation) to the RFQ including the offeror's best and final offer and (3) the acceptance of the response (Quotation) by "notice of award".

In the event where the offeror fails to deliver the supplies/equipment per the agreed contract terms and conditions, JDI will issue a notice of cancellation terminating the contract immediately.

1.3. Chronological List of Events

The following calendar summarizes important dates in the solicitation process. Offerors must strictly follow these deadlines.

The dates above may be modified at the sole discretion of JDI. Any changes will be published/advertised in an amendment to this RFQ on the JDI website.

1.4. Submission and Requirement

The quotations must address the following information at the minimum (Financial & Technical) to JDI.

1.4.1. Offers must be priced in Kshs or USD, signed and dated. The price must clearly demonstrate unit price, total cost inclusive of tax, and any additional expenses associated with delivery and insurance to the final destination.

1.4.2. The offerors must detail their 4WD Station Wagon or Double Cabin 4WD Pickup enough by attaching an available catalog for demonstrating the product features. The offerors may attach a sample of standard manufacturer's warranty.

1.4.3. Offerors are to describe in detail the technical specification of the 4WD Station Wagon or Double Cabin 4WD Pickup including the Model, Brand, Year of product, Warranty (Refer to Section II)

1.4.4. Service and maintenance: offeror must describe how it offers service and maintenance to its customers and vehicles. Offeror must also provide details of the vehicle service and maintenance log sheet for the last 3 years for second hand vehicles.

1.4.5. Past performance: The offerors must provide 3 past performance references of similar work (under contract or sub-contract). This should include both the sale and delivery of a similar vehicle and the servicing afterwards. The offerors must provide contact information of companies including name, point of contact who can speak to the offeror's performance, and address of the companies.

1.4.6 Other: other items that should be included in the quote are delivery times, validity of the quote and a confirmation that offeror can comply with all requirements mentioned in this RFQ (or an explanation where and why not).

1.5. Evaluation and Basis for Award

1.5.1. An award will be made on an all or none basis. Only bids submitted by September 16th, 2022, 5 p.m, with required submittal documents and meeting qualifications will be considered. Failure to submit the required information may be cause for rejection of the offer response. JDI reserves the right to waive informalities and minor irregularities in offers received.

1.5.2. Award: JDI will award a contract to the offeror whose quote is considered to be the Best Value to JDI, price and other factors considered. The following factors may be used to evaluate offers:

1.5.3. Award: JDI reserves the right to consider offerors qualifications, references; conduct studies and other investigations as necessary to evaluate any response; request additional relevant information; disqualify offer based on unsatisfactory reference checks, reports and records of service.

1.6. Delivery and Acceptance

1.6.1 Freight: The offeror is responsible to deliver the 4WD Station Wagon or Double Cabin 4WD Pickup in good condition to JDI's destination of choice, which will be in Nairobi . The offeror is responsible for any damages during shipping or the otherwise not arriving in good working order at the final destination.

The offeror is responsible for all charges including handling, any associated custom fee, and shipping cost to the final destination. The offeror must include any estimated associated fee with the unit price.

1.6.2. Delivery Schedule: Delivery shall not exceed 14 working days from the date of award. The offeror must contact JDI to schedule delivery date and time.

1.6.4. Acceptance, inspection and performance testing will not take more than five (5) working days. Offeror will be notified within this time frame of any units not delivered in full compliance with the order specifications.
