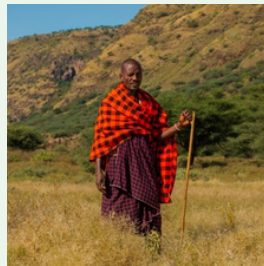
Justdiggit Foundation is registered in the Netherlands, and acts under Dutch law, with offices in Amsterdam, Nairobi and Arusha.
